

# HARBOR NOTICE

## All harbors will officially close on Wednesday October 31, 2018 at 11:59 pm.

- LATE LEAVER permits are available for the designated LATE LEAVER HARBOR, Burnham Harbor. Any vessel left in the harbors after October 31<sup>st</sup> without a "LATE LEAVER" permit may be impounded and the owner will be subject to fines and additional charges. **Boat owners are responsible for taking weather and other factors into consideration when determining when to remove their boats from the harbor.**
- Boaters with a LATE LEAVER permit can stay at the designated docks in Burnham Harbor until Thursday November 15, 2018 at 11:59 pm. LATE LEAVER permits may be purchased online from October 1<sup>st</sup> thru October 30<sup>th</sup> at [www.chicagoharbors.info/lateleaver](http://www.chicagoharbors.info/lateleaver). Commercial Permittees who intend on maintaining a mooring for Late Leaver **must also complete** the late leaver application.
- The LATE LEAVER permit fee is:     \$150.00 for Stalls 30' and under             \$210.00 for Stalls 31' to 50'             \$280.00 for Stalls 51' and over
- PLEASE NOTE:   Weather permitting, WATER service will be left on in ALL harbors until October 15<sup>th</sup>.  
                          ELECTRICAL Service will be left on for the "Late Leaver" harbor until November 15<sup>th</sup>.

## Dock Box and Dock Access Notice

- **All items on the docks and the contents of all dock boxes must be removed by Wednesday, October 31, 2018.** In addition all locks must be removed from the dock boxes. There will also be no security for any docks other than those designated for Late Leavers after October 31<sup>st</sup>. We are not responsible for any items left in any harbor after Wednesday, October 31, 2018.
- Access gates will be chained anytime after October 31<sup>st</sup>. No access to these docks is allowed once the gates have been chained.

## Parking and Parking Card Notices

- The Montrose Harbor north parking lot will close on Tuesday October 9<sup>th</sup>. All vehicles must vacate this lot before Tuesday October 9<sup>th</sup> at 6:00 am. The south harbor parking lot will remain open.
- The 31<sup>st</sup> Street Harbor parking garage will have limited parking beginning Monday October 1<sup>st</sup> and will close on Monday October 15<sup>th</sup>. All vehicles must vacate this lot before Monday October 15<sup>th</sup> at 6:00 am. The west harbor parking lot will remain open and limited parking will be available along designated portions of the driveway. Contact the harbor for more information.
- DuSable Harbor parking will be for paid parking only as of Thursday November 1<sup>st</sup> at 1:00 pm. All vehicles must pay the daily or monthly parking fee after this time and all seasonal parking passes will be de-activated. Vehicles with seasonal parking passes must also vacate this lot before then.
- All late leavers must remove any vehicles from the Burnham Harbor parking lots by Friday November 16<sup>th</sup> at 1:00 pm. Any vehicles remaining will be ticketed and/or towed.
- Parking cards belonging to boaters who do not have a late leaver permit may be deactivated after October 31<sup>st</sup>. **However, all boaters should keep their parking cards if they wish to renew them for the 2019 season, otherwise a replacement fee will apply.**
