Dear Annual Contract Customer,

We want to thank you for joining us for the 2022 boating season. Enclosed is your invoice for summer of 2023 and winter storage for 2023-2024. You can either make payment in full by January 10<sup>th</sup> or make five installment payments as follows:

1/5 payment due January 10<sup>th</sup>, 2023 1/5 payment due February 15, 2023

1/5 payment due April 15, 2023

1/5 payment due June 15, 2023

Balance due August 15, 2023

Please remember that your first payment is due by January 10th, 2023 in order to hold your slip assignment <u>and</u> winter storage for the 2023-2024 season. We will begin the transfer and new applicant assignment process in late January. Therefore, if you do not pay 1/5 of the invoice total due by January 10<sup>th</sup>, your winter storage for the 2023-2024 season will be cancelled and your mooring may be reassigned.

If you wish to cancel your annual contract (removing winter storage), please notify us in writing for an updated invoice and payment plan. Once the annual contract is cancelled you will not be eligible to reinstate for any associated discounts. Winter storage spaces not renewed or cancelled will be issued to the next customer on the waiting list. Please note that our storage facilities were full for the 2022-2023 winter season.

Furthermore, you must make your payments by the due dates or winter storage and any discounts will cancelled.
